Presentation of the Panel:

Public administration is an essential pillar, not only of executive power, but also of civil society. Furthermore, public administration is the vertical and horizontal axis on which the entire governance strategy rests, from the decision-making to the implementation in the daily life of each community.

Given this background, in terms of regulation, public administration must put up with both domestic requirements and with requirements emerging at European level.

Precisely in this background, the need to set objectives for the sustainable development of Romania emerged, given that this concept had already been implemented at European Union level.

The role of the state and therefore of public administration in the context of sustainable development is to strike a balance between the aspirations of the citizen and governance, and this balance should be aimed not only at the citizens of today, but also at future generations.

The idea of sustainable development will therefore take into account the major axes of society (health and welfare, quality education, clean water, sustainable cities and communities, aquatic life, terrestrial life, etc.), axes on which the public administration must base its entire idea of governance.

The studies of this panel shall detail all these aspects both in Romania and in countries of the European Union.
