Presentation of the Panel

Cybercrime describes a category of crimes, including those related to computers and information systems, fraud and forgery related to computers, but also forms such as the dissemination of child pornography in the online environment. Cybercrime is a broad and generic term that refers to crimes committed using computers and the Internet.

The major categories of cybercrimes are attacks on individuals, on property and on government (e.g. identity theft, credit card fraud, copyright infringement, hacking, cyber terrorism, etc.).

Computer crime represents one of the greatest challenges of our century for the entire world, starting from the largest institutions, down to individuals. In Romania, cooperation activities with law enforcement institutions at the national level are carried out permanently. Many countries have laws to combat cybercrime, but enforcement and prosecution can be difficult.

Cybercriminals come from all over the world and often act anonymously, which means that identifying and prosecuting them is difficult for public authorities.

The coordinator of the panel proposes to launch a debate as wide as possible on the analysis of crime in cyberspace in order to contribute to the improvement of the interdisciplinary approach to the problem from the Romanian perspective, but also from the perspective of some European Union States.
